The article discusses the main problems of international tax relations in a globalized economy.

The aim of the study is to characterize the interstate tax problems in the globalized economy and the development directions of their solutions to improve the efficiency of the fiscal sovereignty of states and economies. Through the application of analytical and systematic approach problems in international taxation were identified, comparative legal analysis revealed features of legal regulation of double taxation in different countries, the use of statistical methods made it possible to analyze the dynamics of the volume of corporate income tax in OECD countries.

Identified the main problems encountered in the process of government regulation of the problems of double taxation and reduce the tax base and transfer profits in the offshore.

This research can find its application in the field of finance, taxation and development of draft laws in the Russian tax legislation, in the first part of it, and at the international level in terms of developing a working document - a single international standard (working paper).

Offered the ways of solving the problems of international taxation, among them the development of algorithms, revealing the activities of hybrid companies and the establishment of control over the activities of such companies; setting clear rules against reducing the tax base in each identified country using a mechanism of double taxation. Development of a working document will regulate the activities of national tax systems, as well as to create conditions that prevent the erosion of the tax base for corporate income tax and the elimination of profits in the offshore.

1.3. CONSTRUCTIVE APPROACH TO THE OPTIMIZATION OF THE NEW MECHANISM FOR LEVYING PROPERTY TAXES

Used in the Russian tax base on property tax in the form of residual or carrying amount, is very far from the real value of the relevant property, moreover, this situation not only reduces the revenue side of the budget, but also, in principle, distorts some functional component of the property as a means of performance. Since 2014 in respect of certain properties base on property tax may be defined as their cadastral value. But such a change in the law interpreted unambiguously positive or negative difficult. How important is today fundamentally change the mechanism of levying property tax, because the reform will lead to a sharp increase in the tax burden and, therefore, as a result, the possible tax evasion. In this situation, the problem is reduced to the state balanced application of the new mechanism of levying property tax, which will take into account the interests of all parties taxation, develop and strengthen the new conditions of effective relationships between government, business and society.

The article presents the analysis of inflation targeting influence on the economic growth, which is based on the data for 172 countries for the period from 1980 to 2012. The estimates were obtained by threshold regression with fixed effects and show that there is the critical level of inflation (9% per year). If inflation in the country exceeds this critical level, it leads to slower economic growth, but if inflation is lower 9% per year, negative impact on the economic growth is not observed.

6.1. PROJECT EFFICIENCY EVALUATION METHODOLOGY UNDER INFLATION AND MULTICURRENCY CONSIDERATION

Multicurrency investment project evaluation is usually connected with some difficulties. Methodology of project evaluation in multicurrency and inflation environment is described insufficiently in the books on project analysis. Existing foreign methods are not applicable under conditions of Russian instable economy. Moreover, some Russian textbooks and manuals propose incorrect recommendations that can lead to mistakes when evaluating multicurrency investment projects.

In this article the question of several currencies in relation to the type of multicurrency investment project (one-country, polycountry or transnational) is discussed in details. We propose proper methodology that provides correct estimation regardless of the final choice of calculation currency, give examples of calculations and consider different characters of inflation impact on project cash flows components. We show that estimation of project efficiency characteristics may be performed in any currency and the results will be consistent. Presented models are based on assumption of full information about project parameters and its environment. It is supposed that the duration of the project, discount rates, financial flows at different steps of the project are defined and exchange market is arbitrage free.
